

Moinian Group closes 13,642 s/f of medial office leases at The Galleria

Also leasing space at The Galleria is Dr. Julie E. Russak, M.D. A board certified dermatologist and graduate of NYU School of Medicine, Dr. Russak signed a 10-year, 3,986-square-foot lease on the 12th floor of the building.
