I reported on my November trip to the National Association of Realtors annual conference in New Orleans and meeting with the New York Bar Association. The governors continued their discussion

regarding the proposed accounting rule change from the Financial Accounting Standards board that, if implemented, could severely impact corporations balance sheets negatively.

The governors approved an amendment to the bylaws which will add three board seats for past presidents of the organization to serve as voting members on the board of governors (Bylaws committee chaired by Lavelle). Membership development chair Guy Blake, CCIM reminded everyone that any member who recruits a new member in 2011 will receive a 20% discount on their 2012 NYSCAR state dues. Chapter reports were given by the six chapters regarding successful monthly meetings and events held in their areas.
