

The Feil Org. arranges a 12,280 s/f lease for Team Detroit

According to The Feil Org., a new 12,280 s/f lease at 257 Park Avenue South with Team Detroit has been completed. Brian Feil and Robert Fisher represented Feil; Sacha Zarba, senior VP at CBRE represented the tenant. Brian Palumbo and Michele Frankel worked as in-house legal counsel for Feil; Mark Maltz of Davis & Gilbert LLP represented Team Detroit.

Team Detroit will occupy the entire top floor of 257 Park Ave. South including the rooftop, which is being renovated as a garden deck for employees of the company. Team Detroit is expected to move into their new location in the fall.

"We are excited to provide Team Detroit with their new space at 257 Park Ave. South," said Brian Feil, VP of leasing at The Feil Org. "Since we have had prior WPP divisions as tenants in the past, they knew that we would be able to find the perfect space for their Team Detroit offices here in New York City and get the deal done quickly.
