

## Venable expands corporate practice, hires Berman

Further expanding its New York transactional profile, Venable LLP, Alan Berman has joined the firm's local office as of counsel in its corporate practice group.

Berman joins from Dewey & LeBoeuf, where he was of counsel. He was previously managing partner of the local office of LeBoeuf, Lamb, Greene & MacRae LLP.

Over a 45-year legal career, Berman has advised clients across a full spectrum of commercial and financial transactions. He has represented institutional lenders, investors, investment banks, developers, as well as utilities, insurance companies, global construction companies and high-net-worth individuals in transactions in the U.S. and internationally.
