Building, the Clock Tower and the Miami Marquis and oversaw the sale of its largest assets including the Times Sq. Formerly with the New York City Department of Design & Construction, Landers assisted in the development of the New York Police Academy in College Point, Queens and previously worked at Silverstein Properties. At HFZ, Landers will have responsibility for key development projects applying her analytical skills and construction management experience as well as overseeing the creative agencies

residential site on Second Ave. in Manhattan. He previously worked for a large New York City contractor overseeing projects ranging from high-end condominiums to rentals and universities.
