

## Doody joins Johnson Capital as managing director

This included developing the FHA lending programs within the banks 27 regional community banks headquarter locations. Doody had done the same for Collateral Real Estate Company in Rochester, NY where he had been recruited by the company's CEO and Director of Agency Lending to assist the company to rebuild the FHA loan origination platform after the previous FHA Manager left the firm.

His earlier experience includes positions as Regional Director for Arbor Commercial Mortgage and, before that, WMF Group, where he established and built loan production operations while consistently leading his teams' production efforts. He started his career in banking as a bank auditor.

Mr. Doody is a member of the Mortgage Bankers Association. His charity work includes serving on the Board of Directors of the Greater Rochester YMCA and on the Housing Advisory Counsel for various not-for-profit organizations. Tom graduated from the University if North Carolina with a Bachelor of Science degree in Business Administration and Economics.
