

Glenco, Roseland, Mirado and Sharp break ground on 108-unit building; Project team includes: Minno & Wasko and Mellilo & Bauer

Glenco Residential, in partnership with Roseland (a subsidiary of Mack-Cali Realty Corp.), Mirado Properties and Sharp Management, has broken ground on a new 108-unit rental building.

"Tuckahoe has experienced quality revitalization over the past decade, and this project is further testimony to the vibrant renaissance taking place in our community," said Steve Ecklond, mayor of the village of Tuckahoe. This new project will become the new gateway to our Main St. and we look forward to its completion and to welcoming its residents to their new home town."

The design of the residential building will offer 59 one-bedroom units and 49 two-bedroom units with hard wood flooring, stainless steel appliances, washer/dryers, marble countertops and more. Amenities will include a fitness center with state-of-the-art equipment and yoga studio, a club room, and an expansive outdoor terrace with gardens, a fountain sculpture, a large freestanding stone fireplace pit, and an outdoor kitchen for private entertaining. Parking will be provided in secured, well-lighted underground garages.

"I'm delighted to bring this new residential development to the Tuckahoe, Eastchester and Bronxville communities, and southwestern Westchester County," said Glen Vetromile, Glenco Residential's development partner. "There have been no new housing offerings of this type in this area in nearly two decades. The demand for a quality residential offering with a high amenity package is very strong. We believe couples, singles, people in transition and empty-nesters will like our new community. Not everyone needs or wants a large home and many people want the carefree lifestyle that apartment living offers. Their busy lives limit the time that they can commit to maintaining a residence and they prefer the simplicity of apartment living."

This new building is immediately proximate to several new townhome and condo developments, as well as an array of restaurants, cafés, Starbucks and convenience shops. Metro-North rail service to Grand Central is a four block walk from the project to the Tuckahoe train depot. The project also will feature 3,500 s/f of retail space on Main St. that will soon be brought to market for lease. Inquiries can contact Admiral Real Estate Services Corp. of Bronxville.
