

PWC holds Continuing Ed class presented by HAKS; Focused on "Understanding special Inspections"

PWC's Continuing Ed classes, launched in the fall of 2012, are developing a buzz in the industry. A record turnout at PWC's most recent program presented by HAKS, "Understanding Special Inspections," drew a crowd of architects, contractors and other professionals.
