## Start of \$16.4 million construction at Lion Heart Residence in Cohoes; CPC provides \$9.6 million construction loan and \$3.1 million permanent loan

According to governor Andrew Cuomo, construction at Lion Heart Residences has commenced. Lieutenant governor Robert Duffy joined state and local officials and partners to celebrate the groundbreaking of the 72-unit development that will provide affordable homes for working families and inject millions of dollars into the economy.

The \$16.4 million development features 57 affordable one, two and three-bedroom apartments, as well as 15 fully accessible apartments with support services for residents with developmental disabilities. Lion Heart Residence will meet Green Building and Energy Efficiency initiatives.
