This year-round award-winning program includes a sequenced, age appropriate curriculum that provides a seamless flow of learning and growth across a progressive nine-year time frame. Annually, over 400 children from six communities in Westchester, Bronx and Manhattan, Amityville, NY and Bridgeport, Connecticut participate in the program at no charge to the youth or their families.
