The recently completed distribution center at the Broome Corporate Park is the company's largest, at more than 900,000 s/f and the company is currently constructing its first-ever e-Commerce facility at the site. The cost advantages provided by Broome's ideal location is providing Dick's Sporting Goods the access it needs to serve more than 200 retail stores in the northeast. Mighty industry clusters, workforce and education

Broome is the perfect size for your next opportunity. Broome County's economy is one of Upstate New York's largest, generating nearly \$8 billion in economic activity per year. In addition, Broome and the southern tier region of New York, has the highest concentration of scientists and engineers in the state. In addition, the completion of the \$70 million Smart Energy complex on the Binghamton University campus, the announcement of the Imperium3 Battery Manufacturing on the Huron Campus in Endicott and the growth of clean-energy companies like EthosGen in the Koffman Southern Tier Incubator in downtown Binghamton signal a prime opportunity to connect your company to this education powerhouse.

Also on the horizon is a significant bio-pharma presence with the recently opened Binghamton University School of Pharmacy and Pharmaceutical Sciences. A nationally accredited program, BU's Pharma program will provide the opportunity to link your company to cutting-edge research in the rapidly growing pharma industry.
