



8th annual Real Estate Rockers in Relief concert raises over \$150,000 for NECHAMA – Jewish Response to Disaster

New York, NY Real estate professionals rocked out for charity at the 8th annual Real Estate Rockers in Relief concert, which drew over 750 guests to the city's Irving Plaza.
