## **Romer Debbas, LLP ranks in the top ten of New York City's leading law firms**

Overall, The Real Deal found that the city's top 40 law firms handled \$15 billion worth of buyer-side property sales during the specified timeframe. The Real Deal calculated the rankings by analyzing NYC building sales of \$1 million or more as recorded in ACRIS. The law firms were only credited for deals in which they represented the buyer.

Examining the debt-side, The Real Deal's survey revealed \$26 billion of \$1 million-plus lender-side loans closed among NYC's top 40 law firms. Romer Debbas was credited with \$193.9 million, a total comprised of 158 transactions, earning the 30th spot.
