The 25-acre parcel will be developed into two industrial buildings totaling 400,000 s/f. The development is located off Hwy. 201 within minutes of I-80 offering access to Salt Lake City and the

main arteries connecting it to the rest of the nation.

With its centralized location, Salt Lake City is a main distribution point for the entire Western half of the continental U.S. All major MSAs West of the Mississippi can be reached within 24 hours.
