New York State Association of Realtors Reasonable Modification and Accommodation Law now in effect

The NYS Division of Human Rights published final regulations on May 18, 2022, adding 9 NYCRR 466.15 that provides guidance for compliance for licensees and landlords. The regulations include definitions, examples of reasonable modifications and accommodations as well as a sample copy of the notice. The law and regulation also require real estate licensees and landlords to provide a notice that sets forth the rights a disabled individual has with regard to requesting reasonable modifications or accommodations to or in the "housing accommodation." The notice must be provided at "first substantive contact" with a prospective tenant (Note: The same as the Agency Disclosure Form and the Housing and Anti-Discrimination Disclosure Form.) Brokers are also responsible for posting of the notice conspicuously at all real estate offices and on their websites.
