La Ferla joined AGA in 2015 after earning his Master of Architecture from the City University of New York Spitzer School of Architecture. He is particularly skilled at designing projects at the intersection of sustainability, affordability, and community need. Under his leadership, the AGA in-progress Hudson Hill project in Yonkers, NY received a NYSERDA Buildings of Excellence award for its low carbon design, which uses local materials including granite and native plantings. The award granted \$1 million in funding to further enhance the project's energy efficient design. His deft planning and strategy for every project will carry AGA forward as a strategic partner to developers looking to create affordable housing with quality, impactful design.
