Excerpted from https://www.micron.com/manufacturing-expansion/ny/fact-sheets: Micron has selected Clay, New York, just 10 minutes outside of Syracuse, for the location of the megafab site. Micron intends to invest up to \$100 billion over the next 20-plus years, with the first phase investment of \$20 billion planned by the end of this decade, to build a leading-edge memory megafab in Clay, New York.

This is the largest private investment ever made in New York state history. This new megafab will create nearly 50,000 New York jobs: 9,000 new high-paying Micron jobs and over 40,000 community jobs – including suppliers, contractors and other supporting roles. Micron will begin direct hiring for the megafab in line with the production ramp. Micron's Central New York site could eventually include four 600,000 s/f cleanrooms, accounting for a total of 2.4 million s/f of cleanroom space – the size of approximately 40 U.S. football fields. Production output will ramp in the latter half of the decade, in line with industry demand trends.
