It is located off I-287, the Hutchinson River Pkwy. and I-684, and is near the Westchester County Airport.

Purchase Professional Park offers amenities including an on-site BoBo's Cafe, fitness center, 24/7 building access with camera security, a landscaped courtyard with seating areas, on-site owner management and ] complimentary parking.
